



A BILL FOR AN ORDINANCE

RELATING TO SPECIAL FUNDS.

BE IT ORDAINED by the People of the City and County of Honolulu:

SECTION 1. Purpose.

The purpose of this ordinance is to amend the purpose of the Pauahi Project Expend, HI R-15 Fund.

SECTION 2. Notwithstanding any previous ordinance enacted or resolution adopted by the Council of the City and County of Honolulu to the contrary, monies in the Pauahi Project Expend, HI R-15 Fund may be used to:

1. Facilitate financing of the Pauahi Project redevelopment plan providing for the acquisition, clearance, construction of site improvements, and sale or lease of home, apartment, and commercial sites to private parties for development in accordance with said plans; and
2. Fund any project that is eligible for Community Development Block Grant monies.


