

TO REZONE LAND SITUATED AT HALAWA – PEARL CITY, OAHU, HAWAII  
(AMENDING PORTION OF ZONING MAP NO.7), ORDINANCE NO. 86-133

BE IT ORDAINED by the People of the City and County of Honolulu:

SECTION I. Land situated at Pearl City, Oahu, Hawaii, hereinafter described, is hereby rezoned from P-2 General Preservation District to R-5 Residential District with a 25-foot height limit. The boundaries and area of said Land shall be described as shown on the map attached hereto, marked Exhibit "A" and made a part hereof, and further as TMK: 9-7-059:101.

SECTION II. This ordinance shall take effect upon its approval.




PORTION OF
