



RESOLUTION

RELATING TO THE ACCEPTANCE OF GIFTS TO THE CITY FOR THE MAYOR'S 40<sup>TH</sup> SENIOR RECOGNITION PROGRAM ON APRIL 24, 2006

WHEREAS, Section 13-113 of the Revised Charter of the City and County of Honolulu provides for the acceptance of gifts to the City by the Council of the City and County of Honolulu; and

WHEREAS, Resolution 05-349, CD1, FD1, establishes a policy of the Council on the acceptance of gifts donated to the city executive agencies; and

WHEREAS, the policy provides that an executive agency may request the Council's immediate consideration of a request for acceptance of a gift to the City to allow the agency's time-sensitive use of the gift; and

WHEREAS, through a letter dated April 5, 2006, the Director of the Department of Community Services has submitted a request to the Council for the acceptance of two gifts to the City, one from Aloha Airlines of inter-island roundtrip tickets for two and the other from the Hilton Hawaiian Village of gift certificates for accommodations and dinner for two, which the Department desires to use as awards for the Mayor's 40<sup>th</sup> Senior Recognition Program on April 24, 2006; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body accept the two gifts one valued at \$370.00 from Aloha Airlines and the other valued at \$510.00 from the Hilton Hawaiian Village, that are more further described in the letter dated April 5, 2006, from the Director of the Department of Community Services; and




