


Dear Chair Dela Cruz and Councilmembers:

We have enclosed a proposed Council Resolution accepting the gift to the City. The recommendation for acceptance of the gift by the Managing Director is evidenced by his signature below.



RESOLUTION

WHEREAS, Resolution 05-349, CD1, FD1, establishes a policy of the Council for the solicitation and acceptance of gifts donated to the city executive agencies; and

WHEREAS, the policy provides that an executive agency may request the Council's immediate consideration of a request for acceptance of a gift to the City to allow the agency's time-sensitive use of the gift; and

WHEREAS, through a letter dated May 10, 2006, the Director of the Department of Parks and Recreation Services has submitted a request to the Council and approved by the Managing Director for the acceptance of a gift to the City from HFM FoodService of \$2,500 in funds for the Memorial Day Ceremonies to be held on May 29, 2006;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City and County of Honolulu that this body accept the gift of \$2500 from HFM FoodService, that is more further described in the letter dated May 10, 2006, from the Director of Parks and Recreation; and


