WHEREAS, Resolution 05-349, CD1, FD1, establishes a policy of the Council on the acceptance of gifts donated to city executive agencies; and

WHEREAS, the policy provides that an executive agency may request the Council's immediate consideration of a request for acceptance of a gift to the City to allow the agency's time-sensitive expenditure of the gift; and

WHEREAS, through Mayor's Message 127 (2006), the Managing Director has submitted a request to the Council for acceptance of a gift from Honolulu Festival Foundation of travel to Japan with airfare and other accommodations from October 13 through 18, 2006; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body accepts the gift valued at \$1,800.00 that is further described in Mayor's Message 127 (2006); and


