Your Committee on Public Health, Safety & Welfare, which considered Resolution 07-002 entitled:

"RESOLUTION RELATING TO THE ACCEPTANCE OF A GIFT TO THE HONOLULU FIRE DEPARTMENT (HEREINAFTER HFD) FROM THE FIREMAN'S FUND INSURANCE COMPANY FOR THE HFD'S FIRE PREVENTION BUREAU, EDUCATION SECTION,"

transmitted by Communication D-0981, dated November 30, 2006 from the Honolulu Fire Department, reports as follows:

The purpose of the Resolution is to request Council acceptance, on behalf of the City, of a monetary donation of \$25,000 from the Fireman's Fund Insurance Company. The funds will be used by the Honolulu Fire Department to purchase fire safety education materials for its Fire Prevention Bureau, Education section.

Section 13-113 of the Revised Charter of the City and County of Honolulu 1973, as amended, provides as follows:

The Council, on behalf of the City, may accept gifts or donations of money, securities or other personal property or of real estate or any interest in real estate.


