WHEREAS, Resolution 05-349, CD1, FD1, establishes a policy of the Council for the solicitation and acceptance of gifts donated by the City executive agencies; and

WHEREAS, the policy provides for acceptance of the gift by affirmative action by the Council; and

WHEREAS, through a letter dated March 12, 2007, the Director of the Department of Parks and Recreation has submitted a request for acceptance of a gift to the Council and approved by the Mayor of 6,975 poster tubes with caps valued at \$3,696.75 for the Department's Kaneohe Complex for their programs; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body accept the gift valued at \$3,696.75 from Quiet Storm Distribution, Inc., that is more fully described in the above-mentioned letter dated March 12, 2007, from the Director of Parks and Recreation; and


