



A BILL FOR AN ORDINANCE

RELATING TO INDOOR AMUSEMENT AND RECREATION FACILITIES.

BE IT ORDAINED by the People of the City and County of Honolulu:

SECTION 1. Purpose. The purpose of this ordinance is to amend the Land Use Ordinance to require a conditional use permit-major for indoor amusement and recreation facilities located in the P-2 General Preservation zoning district.

SECTION 2. Table 21-3, Revised Ordinances of Honolulu 1990, as amended ("Master Use Table"), is amended by amending the "Amusement and recreation facilities, indoor" use entry in the "Commerce and Business" category to read as follows:




A BILL FOR AN ORDINANCE


