A BILL FOR AN ORDINANCE TO AMEND PORTIONS OF BOUNDARIES OF THE SPECIAL MANAGEMENT AREA MAP FOR EWA, OAHU, HAWAII.

BE IT ORDAINED by the People of the City and County of Honolulu:

SECTION 1. Purpose. The purpose of this bill is to amend the boundaries of the Special Management Area Map for the Ewa area in order to conform the SMA boundary to the current configuration of the Hoakalei Marina (Ewa Marina).

SECTION 2. Portions of the boundaries of the Special Management Area Map for Ewa as adopted by Ordinance No. 94-63 are hereby amended. The new boundaries shall be as shown on the map attached hereto, marked as Exhibit "A", and incorporated herein by reference and made a part hereof.


