

RESOLUTION

RELATING TO THE ACCEPTANCE OF A GIFT TO THE CITY FOR THE HONOLULU POLICE DEPARTMENT TO SEND DETECTIVE RANDALL PLATT TO ATTEND THE GENERAL DYNAMICS OF CHILD SEXUAL ABUSE TRAINING IN WAILUKU, HAWAII, ON JANUARY 25, 2008

WHEREAS, Section 13-113 of the Revised Charter of the City and County of Honolulu provides for the acceptance of gifts to the City by the Council of the City and County of Honolulu; and

WHEREAS, Resolution 05-349, CD1, FD1, establishes a policy of the Council for the solicitation and acceptance of gifts donated to the City executive agencies; and

WHEREAS, the policy provides for acceptance of the gift by affirmative action by the Council; and

WHEREAS, through a letter dated January 16, 2008, the Police Chief of the Honolulu Police Department (hereinafter HPD) has submitted a request to the Council that was approved by the Managing Director for the acceptance of a gift from the Children's Justice Centers of Hawaii valued at \$149 for Detective Randall Platt to attend the General Dynamics of Child Sexual Abuse Training on January 25, 2008; in Wailuku, Hawaii; and

WHEREAS, the description and value of the gift are set forth in the Declaration of Gift (Exhibit A) and attached hereto; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body accept the gift valued at \$149 that is more fully described in the above-mentioned letter from the Police Chief of the HPD; and


