



## RESOLUTION

### AMENDING THE MEMBERSHIP OF THE COUNCIL'S AGRICULTURAL DEVELOPMENT TASK FORCE.

WHEREAS, through the adoption of Resolution 04-288, CD1, the council created an agricultural development task force to "examine and undertake the actions necessary to enhance the viability of the agricultural industry on Oahu"; and

WHEREAS, the agricultural development task force held its initial meeting on January 10, 2005, and has continued to meet on a variety of agriculture related issues; and

WHEREAS, the council found that the agricultural development task force meetings were productive, and by Resolution 07-52, extended the work of the task force until terminated by the council; and

WHEREAS, Resolution 07-52 also provided that "the task force membership shall remain as presently constituted"; and

WHEREAS, the council finds that it would be beneficial to provide the task force with flexibility with regard to its membership and its ability to appoint new members; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that the membership of the agricultural development task force established by Resolution 04-288, CD1, be amended as follows:

- (1) By providing that the task force membership shall consist of not more than nine and not less than five members; and
- (2) By authorizing the appointment of new members by a majority vote of the task force, subject to final approval of the council chair;
