



RESOLUTION

WHEREAS, Resolution 05-349, CD1, FD1, establishes a policy of the Council for the solicitation and acceptance of gifts donated to the City executive agencies; and

WHEREAS, the policy provides for acceptance of the gift by affirmative action by the Council; and

WHEREAS, through a letter dated February 25, 2008, the Director of the Department of Parks and Recreation has submitted a request for acceptance of a gift to the Council and approved by the Managing Director of a monetary gift of \$6,000 to be used at Honolulu Botanical Gardens; and

WHEREAS, the description and value of the gift are set forth in the Declaration of Gift attached hereto as Exhibit A and incorporated herein; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body accepts the monetary gift of \$6,000 from the Friends of Honolulu Botanical Gardens that is more fully described in the above-mentioned letter dated February 25, 2008, from the Director of the Department of Parks and Recreation; and
