



A BILL FOR AN ORDINANCE

RELATING TO REAL PROPERTY TAXATION.

BE IT ORDAINED by the People of the City and County of Honolulu:

SECTION 1. Purpose. The purpose of this ordinance is (a) to provide that for the 2008-2009 tax year only, the "Improved Residential" class that appears in the 2008 real property assessment notices is the "Residential" class provided for in Section 8-7.1(c)(1)(A), Revised Ordinances of Honolulu, and (b) to confirm that for the 2008-2009 tax year only, any reference to the "Residential" class in the assessment list and subsequent documents used or issued by the Director of Budget and Fiscal Services is a reference to the "Improved Residential" class that appears in the 2008 real property assessment notices.

SECTION 2. For the 2008-2009 tax year only, the "Improved Residential" class that appears in the 2008 real property assessment notices shall be the "Residential" class provided for in Section 8-7.1(c)(1)(A), Revised Ordinances of Honolulu, and any reference to the "Residential" class in the assessment list and subsequent documents used or issued by the Director of Budget and Fiscal Services shall be a reference to the "Improved Residential" class that appears in the 2008 real property assessment notices.

SECTION 3. This ordinance shall take effect upon approval and apply to the tax year July 1, 2008 through June 30, 2009.
