



RESOLUTION

RELATING TO THE NOMINATION OF DANA TAKAHARA-DIAS TO SERVE AS THE DIRECTOR OF CUSTOMER SERVICES OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 4-104.1, Revised Charter of the City and County of Honolulu 1973, as amended ("charter"), requires all department heads and the managing director as nominated by the mayor to be subject to the advice and consent of the council; and

WHEREAS, Section 6-401 of the charter establishes the position of the director of customer services to serve as the administrative head of the department of customer services; and

WHEREAS, Section 6-402 of the charter states that the director of customer services shall:

- (a) Receive complaints and inquiries concerning city policies, programs and operations and promptly answer such complaints or inquiries;
- (b) Fulfill the research and information needs of the city, coordinate a city government records management program, and supervise the city archive of documents and materials;
- (c) Perform motor vehicle driver licensing, commercial driver's licensing, and licensing of businesses, bicycles, mopeds, and dogs;
- (d) Conduct inspection of vehicles and reconstructed vehicles; and
- (e) Administer the motor vehicle registration program, the abandoned vehicle program, and the motor vehicle financial responsibility program;

and

WHEREAS, Section 4-104.1 of the charter requires the director to be a registered voter of the city; and

WHEREAS, the mayor has nominated Dana Takahara-Dias to serve as director of customer services through Mayor's Message 3 (2009); and



RESOLUTION

WHEREAS, after review of the nominee, the council finds that Ms. Takahara-Dias is qualified to serve as director of customer services and deserves confirmation; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that Dana Takahara-Dias is confirmed as the director of customer services of the City and County of Honolulu; and

BE IT FINALLY RESOLVED that copies of this Resolution be transmitted to the mayor and Dana Takahara-Dias.




