**A BILL FOR AN ORDINANCE**

---

RELATING TO REAL PROPERTY TAXATION.

BE IT ORDAINED by the People of the City and County of Honolulu:

SECTION 1. Purpose. The purpose of this ordinance is to conform Section 8-12.11 to the language in Ordinance 07-47.

SECTION 2. Section 8-12.11, Revised Ordinances of Honolulu, 1990, as amended ("Costs—Outcome of Appeal") is amended to read as follows:

**"Sec. 8-12.11        Costs—Outcome of appeal.**

[(a)] In the event of an appeal by a taxpayer to the board of review, [except appeals settled pursuant to Section 8-12.14,] if the appeal is compromised, or sustained as to any amount of the valuation in dispute, the costs deposited shall be returned to the appellant. Otherwise the entire amount of costs deposited shall be retained by the city."

SECTION 3. Ordinance material to be repealed is bracketed. When revising, compiling or printing this ordinance for inclusion in the Revised Ordinances of Honolulu, the revisor of ordinances need not include the brackets or the bracketed material.


