This is to inform you that the Pearl City Neighborhood Board No. 21, at its February 24, 2009 Regular Meeting, approved by a 8-0-0 vote, the submittal of the following C.I.P. projects for inclusion in the City's F.Y. 2010 Budget.

Addition of 30 Perimeter Parking Stalls along Waimano Home Road for Manana Community Park: Design and Construction.

This is not the first request for this project. Ever since the Manana Community Park was completed some years ago, it has been the aim of the Pearl City Neighborhood Board No. 21, as a participating member of the Pearl City Task Force, to observe and monitor the operation of this beautiful City facility.

The initial site plan of the community park indicated and provided inadequate amount of perimeter parking along Waimano Home Road for the proposed recreational uses.

Occurrences, especially on weekends and during the Pearl City Pop Warner football season(s) and other ongoing sports activities by other communities in the Leeward Dist., where adequate parking spaces was lacking, emphasizes the fact and made it obvious that there is a need to provide this needed improvement.

Your positive notification that our input has been made part of the F.Y. 2010 C.I.P. Budget would be very much appreciated.


