
Subject: Report of Gift Valued in Excess of \$2,500 and Requested Acceptance

The gift of cash in the amount of \$17,000 from Shinnyo En Hawaii is for McCoy Pavilion and Ala Moana Regional Park maintenance.



WHEREAS, Resolution No. 05-349 CD1, FD1, establishes a policy of the Council for the solicitation and acceptance of gifts donated to the City executive agencies; and

WHEREAS, the policy provides for acceptance of the gift by affirmative action by the Council; and

WHEREAS, through a letter, the Director of Department of Parks and Recreation, has submitted a request for acceptance of a gift to the Council and approved by the Managing Director of funds valued at \$8,500 for McCoy Pavilion and \$8,500 for Ala Moana Regional Park maintenance; and
