

The International Association of Chiefs of Police (IACP), will convene a National Policy Summit on ***Building Safe Communities: Improving Police Response to Persons with Mental Illness*** on May 7th and 8th in Alexandria, Virginia. Approximately 100 leaders in law enforcement, courts, corrections, community mental health providers, advocates, consumers, youth and family members will be invited to participate. Based on your expertise in this policy area, we invite you to join us.

The summit is a collaborative effort of the IACP, the JEHT Foundation, the United States Department of Health and Human Services/Substance Abuse and Mental Health Services Administration (SAMHSA), and the United States Department of Justice, Bureau of Justice Assistance. All summit partners hope that the summit results in the development of national guidelines to assist law enforcement agencies and their community partners in creating positive outcomes to mental health crisis calls across the country.

The summit will address all aspects of this critical response issue, including reducing trauma, injury or death outcomes during mental health crisis calls. We also believe the summit will promote dialogue between law enforcement, community providers and partners that will sustain short and long term improvement in crisis call response, treatment and recovery around the United States.

Travel, lodging and meal expenses will be covered by summit funding. Upon receiving confirmation from those who are out of state, Ms. Magnini will direct you to David Lippe, IACP Travel
