



A BILL FOR AN ORDINANCE

RELATING TO FEES FOR AFTER-SCHOOL PROGRAMS.

BE IT ORDAINED by the People of the City and County of Honolulu:

SECTION 1. The purpose of this ordinance is to authorize fees for after-school programs run by the department of parks and recreation, as permitted under Section 302A-408, Hawaii Revised Statutes.

SECTION 2. Chapter 10, Revised Ordinances of Honolulu 1990, ("Rules, Regulations, Charges and Fees for Public Parks and Recreation Facilities") is amended by adding a new article to be appropriately designated by the revisor of ordinances and to read as follows:

"Article ____ . After-School Programs

Sec. 10-__ .1 Definitions.

As used in this article:

"After-school program" means a program of activities for children, including but not limited to child-care, held at public school and public park facilities by the city after regular school hours.

"Department" means the department of parks and recreation.

Sec. 10-__ .2 Fees for participation in after-school programs.

The department may charge a fee set by administrative rules for each child who is registered as a participant in an after-school program. The department shall adopt rules pursuant to Chapter 91, HRS, to establish the fee, and for the administration and implementation of this article. Proceeds from the fee assessed under this section shall be used to defray the cost of running after-school programs."




