

Subject: Request for Council Acceptance of a Gift to the City

We respectfully request the acceptance by the Council, on behalf of the City and County of Honolulu, of a gift to the City from CrimeStoppers Honolulu, Inc. in the amount of \$3,000. This request is made under the provisions of Resolution No. 05-349, C.D.1, F.D.1. The Honolulu Police Department (HPD) desires expenditure of the gift valued at \$3,000 to enable Sergeant Kim Buffett of the Criminal Investigation Division to attend the CrimeStoppers International Training Conference in Queensland, Australia, from October 11 through 14, 2009. We have attached a proposed resolution for the favorable action of the Council.

On October 13, 2009, Captain Sean Naito of the Criminal Investigation Division promptly notified Senior Advisor Kimberly Ribellia of Councilmember Dela Cruz's Office regarding the receipt of a gift and requested that the Public Safety and Service Committee waive holding a hearing on the resolution. He informed Ms. Ribellia that the pertinent documents are being processed and would be submitted once all approvals were obtained.

Therefore, due to time constraints, we ask that the City Council approve the acceptance of the gift at the October 27, 2009, Council meeting.



RESOLUTION

RELATING TO THE ACCEPTANCE OF A GIFT TO THE CITY FOR THE HONOLULU POLICE DEPARTMENT TO SEND SERGEANT KIM BUFFETT TO ATTEND THE CRIMESTOPPERS INTERNATIONAL TRAINING CONFERENCE IN QUEENSLAND, AUSTRALIA, FROM OCTOBER 11 THROUGH 14, 2009.

WHEREAS, Section 13-113 of the Revised Charter of the City and County of Honolulu provides for the acceptance of gifts to the City by the Council of the City and County of Honolulu; and

WHEREAS, Resolution 05-349, C.D.1, F.D.1, establishes a policy of the Council for the solicitation and acceptance of gifts donated to the City executive agencies; and

WHEREAS, the policy provides for acceptance of the gift by affirmative action by the Council; and

WHEREAS, through a letter dated October 14, 2009, the Acting Police Chief of the Honolulu Police Department (hereinafter HPD) has submitted a request to the Council that was approved by the Managing Director for the acceptance of a gift from CrimeStoppers Honolulu, Inc. valued at \$3,000 for Sergeant Kim Buffett to attend the CrimeStoppers International Training Conference in Queensland, Australia, from October 11 through 14, 2009.

WHEREAS, the description and value of the gift are set forth in the Declaration of Gift (Exhibit A) and incorporated herein; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body accepts the gift valued at \$3,000 that is more fully described in the above-mentioned letter from the Chief of Police of the HPD; and


