

## RESOLUTION

RELATING TO THE ACCEPTANCE OF THE GIFT TO THE CITY FROM SAVE OAHU'S RACE TRACKS, LLC, OF 34 CEMENT BARRICADES FOR ONEULA BEACH PARK, EWA BEACH

WHEREAS, SECTION 13-113 of the Revised Charter of the City and County of Honolulu provides for the acceptance of gifts to the City by the Council of the City and County of Honolulu; and

WHEREAS, Resolution No. 05-349, CD1, FD1, establishes a policy of the Council for the solicitation and acceptance of gifts donated to the City executive agencies; and

WHEREAS, the policy provides for acceptance of the gift by affirmative action by the Council; and

WHEREAS, through a letter, the Director of the Department of Parks and Recreation, has submitted a request for acceptance of a gift to the Council and approved by the Managing Director of 34 cement barricades valued in the amount of \$34,000 from Save Oahu's Race Tracks, LLC, used at Oneula Beach Park, for a cleanup and beautification project; and,

WHEREAS, the description and value of the gift is set forth in the Declaration of Gift (Exhibit A) and incorporated herein; now therefore;

BE IT RESOLVED by the Council of the City and County of Honolulu that this body accept the gift valued at \$34,000 from Save Oahu's Race Tracks, LLC, that is more fully described in the above-mentioned letter from the Director of the Department of Parks and Recreation; and
