



## RESOLUTION

TO REQUEST ADDITIONAL FUNDS FOR CONTRACT NO. SC-COR-1700022 TO CONTINUE THE SERVICES OF CHONG, NISHIMOTO, SIA, NAKAMURA, & GOYA, LLP AS SPECIAL COUNSEL FOR THE CITY AND COUNTY OF HONOLULU TO REPRESENT DEFENDANTS HONOLULU ETHICS COMMISSION AND THE CITY AND COUNTY OF HONOLULU IN A LEGAL ACTION ENTITLED, KEALOHA, ET AL. V. TOTTO, ET AL., CIVIL NO. 16-1-1166-6 GWBC.

WHEREAS, by way of Resolution No.16-221, the Council of the City and County of Honolulu ("Council") approved the retention of the law firm of Chong, Nishimoto, Sia, Nakamura & Goya, LLP ("Special Counsel"), to represent and defend the interests of the Honolulu Ethic Commission and the City and County of Honolulu, named as Defendants in the civil action entitled Kealoha, et al. v. Tutto, et al., Civil No.16-1-1166-6 GWBC; and

WHEREAS, by way of Resolution No. 16-221, Council authorized an allotment to Special Counsel in the maximum of \$100,000.00 for legal fees and costs in the defense of the above-referenced Defendants in the above-referenced lawsuit; and

WHEREAS, to date, Special Counsel has billed the City a total \$95,581.42, and has indicated that additional funds are necessary; and

WHEREAS, Special Counsel has requested the approval of additional funds to cover anticipated legal fees and costs in defense of Defendants Honolulu Ethics Commission and the City in the lawsuit; and

WHEREAS, based on the above, it appears that an increase in the amount of fees is warranted and Corporation Counsel has recommended the allotment of additional sums; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu, pursuant to the mandate of Sections 5-203 and 5-204.3 of the Revised Charter of the City and County of Honolulu 1973, as amended, that an additional \$100,000.00 be allotted for payment of the law firm of Chong, Nishimoto, Sia, Nakamura & Goya, LLP, in accordance with all the terms and conditions set forth in Resolution No. 16-221, bringing the total amount authorized by Council resolution to \$200,000.00; and


